**Club Tarneit
Chance to Win \$100,000
Terms and Conditions**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is Club Tarneit 622 Leakes Road, Tarneit, VIC 3029
3. Entry is open to members of Club Tarneit who are Victorian residents, aged 18 years or over.
4. Employees and immediate family of employees are not eligible for entry. This includes: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or adopted), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister, or first cousin.
5. Entries into the Promotion open on September 30, 2024 and close at 11:59PM on November 13, 2024. ("Promotional Period").
6. To be eligible to enter and considered an "Eligible Entrant", entrants must, during the Promotional Period be a member of Club Tarneit, and spend \$20 at any of our tills at Club Tarneit, or be awarded a random entry.
7. From September 30, 2024 to November 13, 2024, entry tickets will be issued across our venue, to anyone who spends \$20 or over in a single transaction. Additionally, 9 random in venue members will be selected daily and given a bonus entry.
8. To enter for an invitation to attend the Gala Night draw and the chance to win \$100,000, the customer places their promotional ticket into the barrel provided at the Club
9. Daily Draws:
 - i. From September 30, 2024 until November 13, 2024 (inclusive) at 11 am, 2pm, 7pm and 10pm daily an entry is drawn from the barrel and the customer receives an invite to the VIP Gala night where they will have the chance to win \$100,000.
 - ii. If a customer is present in the venue and comes to reception when their name is drawn, they will receive an invite to the gala night and an instant \$100 cash bonus. If not claimed, they will be contacted by the reception team.
 - iii. If the customer is not present the reception team will ring them, congratulate them and invite them to come in to get their invitation.
 - iv. Invitations are not transferrable, unless the registered winner nominats a proxy, as per these terms and conditions.
10. VIP Gala night: At the end of the promo on November 13, 2024 before the Gala night, the barrel is emptied. Invited customers return to the Gala night on November 14, 2024 from 6pm, where they register, (registration closes at 7pm) and receive a new entry form to place into the barrel for the

chance to win \$100,000 and 19 minor prizes. Invited customers will be asked to show appropriate identification when registering. If the customer is unable to attend, or they are the recipient of multiple invitations, they may nominate a proxy (over the age of 18yrs) via written correspondence by email to melissa@clubtarneit.com.au by 4pm November 14, 2024. One proxy per invite. Proxy will be required to present photo ID on Gala Night.

11. There will be one main \$100,000 draw. There will be 99 green keys that have a number from 1 – 99 on them. We will have 1 golden key. All keys will be placed into a black security bag. One customer will be drawn from the barrel, they then can place their hand in the bag and if they pick the gold key they win the \$100,000. If they pick a green key they win the prize associated with that number.
12. The draw will be supervised by Simon Roach from Loyalty.com.au or a nominated supervisor.
13. Supplementary Draws: The Master of Ceremonies will take out the gold key, if it wasn't chosen, and select 19 more customers who will pick a key. There will be 19 prize envelopes on display during the Gala Night. Each prize envelope will be numbered in ranges (e.g., 1-5, 6-10, etc.). Inside each envelope will be a mystery prize, which could be a voucher, hamper, or similar item, with retail values ranging from \$50 to \$500. These envelopes will be opened by the winners based on the key number selected. The winners must be in attendance, if the winner is not in attendance the Master of Ceremonies will redraw.
14. The Promoter reserves the right, at any time, to verify the validity of entries and Eligible Entrants (including an Eligible Entrant's identity) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
15. Incomplete or indecipherable entries will be deemed invalid, and therefore not entered/eligible to win.
16. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

The Promoter will not be responsible for banking institutions rejecting an EFT payment, or any costs associated with locating any lost prizes. The Promoter is not responsible for any payments that have been successfully transferred into an incorrect nominated bank account. In these cases, there will be no further payments made. Allow 28 business days for the funds to be transferred in the case of \$100,000 winner.

Except for any liability that cannot by law be excluded, including the Non- Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.

Except for any liability that cannot by law be excluded, including the Non- Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize entry that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or Eligible Entrant; or (f) use of a prize.

To the extent that a situation or issue arises for which these Terms and Conditions make no provision or in relation to which the relevant Terms and Conditions are unclear, the Promoter will make a decision regarding such situation. You will have the right to request an internal review of the Promoter's decision. Subject to any regulatory direction to the contrary, the decision of the internal review will be final and binding.
