

Club Tarneit Member's Draw Terms and Conditions

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
- 2. The Promoter is Club Tarneit 622 Leakes Road, Tarneit, VIC 3029
- 3. Entry is open to members of Club Tarneit who are Victorian residents, aged 18 years or over.
- 4. Employees and immediate family of employees are not eligible for entry. This includes: spouse, exspouse, de-facto spouse, child or step-child (whether natural or adopted), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister, first cousin or in-law.
- 5. The Promotion runs on Thursday nights in venue.
- 6. To be eligible to enter and considered an "Eligible Entrant", entrants must, during the Promotional Period be a member of Club Tarneit..
- 7. Only members in venue at the time of the draw will be eligible to win. If the member number drawn is not in venue, the prize will jackpot.

8. Prize Details:

- i. Each Thursday night at 7:00 pm, 8:00 pm, and 9:00 pm, a member will be randomly selected to win the jackpot, which starts at \$1,000.
- ii. If the selected member is present at the venue and reports to reception when their name is drawn, they will receive the prize amount available at the time of the draw.
- iii. If the member is not present, the jackpot will increase by \$100.
- iv. The prize pool will continue to grow in \$100 increments until it is won or reaches a cap of \$5,000.
- v. If the jackpot reaches the \$5,000 cap and is not won, a raffle will be held on the same night for members on-site. Five prizes of \$1,000 will be distributed to the members with winning raffle tickets.
- 9. The draw will be supervised by a Manager on Duty.
- 10. The Promoter reserves the right, at any time, to verify the validity of Eligible Entrants (including an Eligible Entrant's identity) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion.
